<i>Oversight/</i> <i>Accountability</i>	ECO Coordinator John Walsh shared there are opportunities to serve April 26, need (up to 13) commissioners for a 10AM Zoom meeting to prepare for September 20-21 ECO meeting in San Antonio. The meeting in San Antonio is an opportunity to network with the other 35 Texas Presbytery churches. We are allotted 14 commissioners (1 for each ordained pastor).
	Operations Committee Financially we are in a strong position. Giving in Feb was \$20K > 2023. Operations are under budget by > \$300K – primarily due to unfilled positions. We have made \$190K in investment returns.
	Columbarium is down to 6 unsold niches. Art Harding chairing a committee to enlarge the Columbarium.
	Lana and Justin have helped Audit committee move forward with more timely Audits.
	Governance Coordinating Committee Justin Eastburn gave an encouraging update on the work of the Slate Making Task Force. 85 nominees completed the "application process". Names for PNC should be announced after April 8 th .
	• A Motion was made and approved to hold a Congregational Meeting to elect / approve Pastor Nominating Committee after the 11 AM service on April 28, 2024.
	Craig Murray read a statement explaining The Clerk of the Session has received a formal communication from a covenant partner expressing concern over the church's process and handling of alleged sexual misconduct of one adult to another that took place outside of HP Pres campus during a non-church related activity.
	After discussion, the Session directed the Head of Staff to assess current policies, procedures, and training to determine if steps can be taken to improve the handling of alleged cases of sexual misconduct; and that the Head of Staff provide a report to the Session by September 2024 of any findings, recommendations, and/or changes to policies and procedures

Motion to the Session from the ECO Coordinator, April 22, 2024

Motion: "It is moved to approve the following individuals - Neil Rambin, John Walsh Alisa Sell and Angie Vaughn - to represent HPPres as Elder Commissioners at the next ECO Texas Presbytery Meeting which will be held as a virtual meeting on April 26, 2024, and to delegate authority to the SLT and John Walsh to select additional elders to be Commissioners for the meeting up to the allotted 13 elders allowed to represent us under ECO polity."

For information purposes:

The Texas Presbytery will gather via Zoom on Friday, April 26, 2024 from 10 to 11a.m. The agenda will be largely composed of a vote to ratify the constitutional amendments that were approved at the Synod meeting earlier this year along with a report from our ministry partnership team and updates from the churches in our presbytery.

For matters that require approval by the Presbytery, only pastor and elder commissioners will be eligible to vote. A church's pastor commissioners are the ECO pastors in service to that congregation. Additionally, each church may select elder commissioners from its covenant partners that have been elected as elders in a number equal to the number of its pastor commissioners. For example, If a church has a lead pastor and an associate pastor, they may select two elder commissioners, one for each pastor commissioner. If a church does not currently have a pastor, they are entitled to one elder commissioner

Ryan Tompkins

Ryan grew up in the rolling hills of upstate New York in a Christian home and in a church that was gospel-proclaiming and disciple-making. Ryan completed his undergraduate education at the SUNY Buffalo and started his professional career as a teacher.

After marrying and moving to New York City, Ryan and his wife, Jennifer, moved to Philadelphia so that Ryan could attend Westminster Theological Seminary. After seminary, Ryan was ordained in the Presbyterian Church in America (PCA) and joined the staff at Redeemer Presbyterian Church in Manhattan. After three years in pastoral ministry and the addition of two girls to his family, Ryan took the senior pastor position at Rockwall Presbyterian Church, where he spent 13 years ministering.

In Rockwall, Ryan and Jennifer adopted a third child, and Ryan completed a D Min at Baylor. In 2019, Ryan moved his family into Dallas while completing a master's degree in professional counseling. Ryan completed his hours for his counseling license at Children's Medical Center in Dallas, The Center Counseling, and Sparrow House Counseling. In the fall of 2024, Ryan opened his own practice and started doing work with Highland Park Presbyterian Church, which culminated in a pastoral position in counseling and care. Ryan loves to think deeply about soul care, and he counts it a privilege to be laboring with the staff at HP Pres.
